Integrated Pest Management (IPM)

Integrated Pest Management (IPM) is an effective and environmentally sensitive approach to pest management that relies on a combination of common-sense practices. IPM programs use current, comprehensive information on the life cycles of pests and their interaction with the environment.



Integrated Pest Management Program in ILPC

IPM is not a single pest control method but, rather, a series of pest management evaluations, decisions and controls. In practicing IPM, we at ILPC follow a three-tiered approach. The three steps include:

1. Set Action Thresholds

Before taking any pest control action, ILPC first sets an action threshold, a point at which pest populations or environmental conditions indicate that pest control action must be taken. Sighting a single pest does not always mean control is needed. The level at which pests will either become an economic threat is critical to guide future pest control decisions.

2. Monitor and Identify Pests

Not all insects, weeds, and other living organisms require control. Many organisms are innocuous, and some are even beneficial. ILPC IPM programs work to monitor for pests and identify them accurately, so that appropriate control decisions can be made in conjunction with action thresholds.

3. Control

Once monitoring, identification, and action thresholds indicate that pest control is required, ILPC IPM programs then evaluate the proper control method both for effectiveness and risk. Effective, less risky pest controls are chosen first, including highly targeted medicines, or mechanical control, such as trapping.



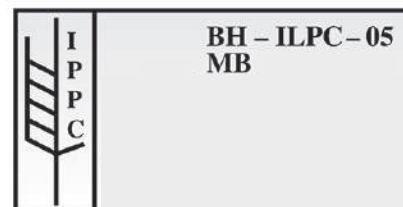

The International Plant Protection Convention (IPPC) is an intergovernmental treaty signed by over 180 countries, aiming to protecting the world's plant resources from the spread and introduction of pests, and promoting safe trade.

The IPPC is one of the "Three Sisters" recognized by the World Trade Organization's (WTO) Sanitary and Phytosanitary Measures (SPS) Agreement, along with the Codex Alimentarius Commission for food safety standards and the World Organization for Animal Health (OIE) for animal health standards.



ISPM-15

ISPM-15, International Standards for Phytosanitary Measures #15 was created by the International Plant Protection Convention (IPPC), a part of the United Nation's Food and Agriculture Organization. The standard addresses the need to have all wood packaging made of softwood or hardwood species treated. It requires packaging that has been treated to carry a special mark to certify it as such. The treatment could be for each individual piece or the completed packaging and the method of treatment could be either via heat treatment (HT) or fumigation with Methyl Bromide (MB).
